# Course Details

## Duration:

12 months Pre-Sea Training course followed by 18 months of Structured Shipboard Training as TNOc (Deck Cadet)

## Minimum Requirements:

- Pass in (10+2) or equivalent examination with Physics, Chemistry, Mathematics and English as separate subjects with a PCM average of not less than 60%

OR

- B.Sc. in Physics, Mathematics, Chemistry or Electronics with Physics as individual subject in one of the year, with an average of not less than 60% of marks in the final year

OR

- B.E./B. Tech. Degree from I.I.T. or from a college recognized by AICTE with an average of not less than 50% of marks in the final year

- Minimum 50% marks in English language at 10 or 12 Std or in the Degree course conducted by recognized Board or any University.

**Note:** Selection of the candidates is subject to clearing the Combined Entrance Test conducted by Indian Maritime University as well as the internal requirements of GEIMS. The details and the forms can be seen on the Web site: [www.imu.edu.in](http://www.imu.edu.in) Two batches are conducted in a year commencing on January/February and August every year.

## Age Limit:

Not more than 25 years on the date of commencement of the course.

## Application Fees:

INR 750

Candidates who have appeared for improvement examination or compartment/supplementary must have appeared in the same examination board for the improvement/compartment/supplementary exam. **If they change boards for the same, they are ineligible.**

**Candidates to check their eligibility and fill application only if they meet the criteria.**

# Medical Requirements

## Physical Standards:

- Candidates should be healthy and physically fit for sea service as per STCW 2010/MS Medical rules 2000 and all its amendment as applicable to seafarers.

- Aspirants to note that they have to undergo their medical examination with the company appointed DG Shipping approved doctor only. Any medical report acquired otherwise is **inadmissible and the candidate will have to undergo a medical examination with the company appointed doctor.**

- If the candidates want to check their fitness before undergoing the process, they are requested to get in touch with us over e-mail/phone. The candidate will have to bear the costs of such a test and the admissions team will only help arrange for such a test.

## Eyesight:

- 6/6 in each eye without visual aids.
- Normal colour vision.



# Admission Process

## Step by step admission process to join GEIMS:

- **Step 1:** Apply online at [geinstitute.com](http://geinstitute.com) for the course you want to join and pay the examination fees.
- **Step 2:** You will receive a link over e-mail for an online examination that can be taken at any location. You will need to have a proper internet connection to do the same.
  - The login details as well as other instructions shall be provided in the e-mail.
  - Please make sure you provide the correct credentials (e-mail and phone number) while application.
  - Link will be sent by our assessment partners.

- **Step 3:** If you clear the cut-offs (mentioned in the Online Examination Section), you shall receive an e-mail invite to appear for Personal Interview at either Mumbai or Lonavala. The details of the venue will be sent on the e-mail. The interview venue is decided in advance and is at the sole discretion of GEIMS. Candidate shall not be given a preference to chose a date.
- **Step 4:** Those candidates who are selected in the personal interview shall undergo a medical test with the company appointed doctor.
- **Step 5:** A merit list shall be put out on the institute website taking into account past academic scores, online examination scores, interview scores as well as medical examination results.
- **Step 6:** The candidates who make it to the merit list shall be asked to pay a booking amount to reserve their seat. They will also be asked to submit/send necessary documents to the Admissions Team.
- **Step 7:** After receiving the booking amount, the candidates will be issued with a sponsorship letter on the basis of which they can avail loans. We have a tie-up with State Bank of India for the loan process. The details of this shall be intimated to the candidates.

- **Step 8:** The candidates shall receive a joining instructions as well as other documents that they need to submit before they join. Candidates are encouraged to read the instructions carefully.
- **Step 9:** The candidates to report on the morning the course commences at GEIMS, Lonavala. The reporting date and time shall be intimated to the candidates.

## FAQs

- **Will accommodation be provided during the interview process?**

No, the institute does not provide accommodation. Candidates and accompanying guardians are to make their own arrangements for accommodation.

- **Is the booking amount/fees refundable?**

The fees and/or booking amount is not refundable under any circumstances.

- **Does the institute reimburse expenses incidental to the process?**

# Key Timelines & Details

- Last Date for applying on the website: **3rd July 2020**
- AMCAT Assessment Link: Sent once the admission process begins
- Interview: To be held around **mid-April**
- Interview Venue: Mumbai/ Lonavala (Shall be intimated adequately prior to the process).

## IMU Details

- Candidates to note that they it is **mandatory for them to clear the IMU CET exam (apart from GEIMS' internal process) to qualify for admission at GEIMS**. The IMU CET is conducted twice a year by IMU, Chennai and is a pen and paper based test. IMU – CET Subjects: (100 marks for 100 questions for the following four subjects) at 10+2 level (CBSE, ISE & STATE BOARDS).
  - English --- 25 Marks
  - Physics – 25 Marks
  - Mathematics – 25 Marks
  - Chemistry –25 Marks
- Candidates are requested to visit IMU's website ([www.imu.edu.in](http://www.imu.edu.in)) periodically to keep track of new announcements and changes if any.
- **GE Shipping/ GEIMS shall not be responsible** if any candidate is put to hardship because he/she did not keep himself abreast of the latest developments. Only Candidates who have passed the CET, and who fulfill the eligibility criteria relating to age, education qualifications, medical fitness etc. as per IMU norms shall be eligible for admission to DNS Feb 2020 batch.



# How to apply?

- Applicants who meet the eligibility criteria should apply by filling the Online Application Form on the website.
- The Application should be submitted in the format given in the website only, with one recent passport size photograph pasted neatly in the right hand top corner.
- After making the online payment, please send an e-mail to **academy@greatship.com** with the following details:

- Communication regarding the exact interview date and time will be communicated to the applicants in due course of time. Applicants are requested to check the website and their registered e-mail ID continuously for details.
- Candidates must ensure they provide their correct email-id and phone number/mobile number in the online application form as they will receive the Test Login details on the email id mentioned in the application form.

## Career Path

- The total training period is 30 months - 12 months on-shore and 18 months on board a ship as a Deck Cadet (TNOG)
- After completion of training, it is mandatory to clear the examinations conducted by MMD and obtain requisite Certificate of Competency.
- The rank structure among deck officers is mentioned in an ascending order below:
  - Deck Cadet
  - 3rd Officer
  - 2nd Officer
  - Chief Officer
  - Master

## Stipend

Stipend during the training period shall be determined by the market conditions as well as the organization that the trainees join for their training period.

## Employment

The Offer of admission for Pre-Sea Training and Shipboard Training by GES shall not be considered as guarantee of employment on completion of such training. However, in the event of GES offering employment after passing the Examination, the candidate shall agree to be bound to accept our employment and serve on our vessels for a period of three years. This is a requirement as per the Gazette Notification S.O.2132 (E) issued on December 12, 2007 by Govt. of India.

## Fees Payment - Key Points

- Please note that the fee structure is tentative and is subject to change.
- Applicants to take note of the fact that the fees is non-refundable under any circumstances.
- The payments are to completed only via NEFT (bank transfer). No other means of payment (DD/ Cheque) will be accepted.
- The fee payment is made in 2 parts: in the first part, Admission and Orientation fees is paid; the second part of fees is to be paid by the date of commencement of the course.
