Course Details

Duration:

4 months (on shore) plus 8 months (on board)

Minimum Requirements:

- Passed 10+2 with Physics, Chemistry, Mathematics and English as separate subjects with minimum 50 % marks in English Language at 10th of 12th standard exam.
- Passed 3 year Diploma with 60% marks OR Passed four year's Degree including lateral entry, with 60% marks in Electrical Engineering, Electronics Engineering, Electrical and Electronics Engineering, Electronics and Telecommunication / Communication Engineering, or Electronics and instrumentation or equivalent.

- The diploma /degree courses must have been recognized by any State or Central Government or the AICTE.

Age Limit:

Not more than 25 years on the date of commencement of the course.

INR 750 (non-refundable)

Students who have appeared for the final year examinations, must produce original mark-sheets for all 8 semesters as well as a provisional degree on the commencement of the course.

Students who have cleared their BE/BTech final year but are yet to clear any backlog of prior semesters are ineligible to apply.

Candidates to check their eligibility and fill application only if they meet the criteria.

BTech/ BE degree OR Diploma is mandatory for admission to this program.

Medical Requirements

Physical Standards:

- Candidates should be healthy and physically fit for sea service as per STCW 2010/MS Medical rules 2000 and all its amendment as applicable to seafarers.
- Aspirants to note that they have to undergo their medical examination with the company appointed DG Shipping approved doctor only. Any medical report acquired otherwise is **inadmissible and the candidate will have to undergo a medical examination with the company appointed doctor.**
- If the candidates want to check their fitness before undergoing the process, they are requested to get in touch with us over e-mail. The candidate will have to bear the costs of such a test and the admissions team will only help arrange for such a test.

Eyesight:

- Distance vision (unaided) : 6/12 in each eye; or 6/9 in better eye and 6/18 in other eye.

Admission Process

Step by step admission process to join GEIMS:

- **Step 1:** Apply online at geinstitute.com for the course you want to join and pay the examination fees.
- **Step 2:** You will receive a link over e-mail for an online examination that can be taken at any location. You will need to have a proper internet connection to do the same.
 - The login details as well as other instructions shall be provided in the e-mail.
 - Please make sure you provide the correct credentials (e-mail and phone number) while application.
 - Link will be sent by our assessment partners.

- **Step 3:** If you clear the cut-offs (mentioned in the Online Examination Section), you shall receive an e-mail invite to appear for Personal Interview at either Mumbai or Lonavala. The details of the venue will be sent on the e-mail. The interview venue is decided in advance and is at the sole discretion of GEIMS. Candidate shall not be given a preference to select.
- **Step 4:** Those candidates who are selected in the personal interview shall undergo a medical test with the company appointed doctor.
- **Step 5:** A merit list will be derived taking into account past academic scores, online examination scores, interview scores as well as medical examination results.
- **Step 6:** The candidates who make it to the merit list will be informed via mail and shall be asked to pay a booking amount to reserve their seat.
- **Step 7:** After receiving the booking amount, the candidates will be issued with a sponsorship letter on the basis of which they can avail loan. We have a tie-up with State Bank of India for the loan process. The details of this shall be intimated to the candidates.

- **Step 8:** The candidates shall receive a joining instructions as well as other documents that they need to submit before they join. Candidates are encouraged to read the instructions carefully.
- **Step 9:** The candidates to report on the morning the course commences at GEIMS, Lonavala. The reporting date and time shall be intimated to the candidates.

FAQs

- **Will accommodation be provided during the interview process?**

No, the institute does not provide accommodation. Candidates and accompanying guardians are to make their own arrangements for accommodation.

- **Is the booking amount/fees refundable?**
