# Course Details

## **Duration:**

8 months (on shore) plus 10 months (on board)

## **Minimum Requirements:**

- BE /BTECH (Mechanical Engineering) or BE / BTECH (Mechanical/Marine) with minimum marks of 55% aggregate in Degree.

- Minimum 55% marks in English subject at 10th or 12th or in Degree Exam conducted by a recognized board or University.

- Please check thoroughly if you meet the requirements and apply after that.

## **Age Limit:**

Not more than 26 years on the date of commencement of the course.

Students who have appeared for BE/BTech (Mechanical Engineering) final year should have original marksheets for all 8 semesters and at least Provisional Degree from University before the course commencement date

Students who are confident of having their Provisional Degree and mark sheets for all 8 semesters before 1st Jan 2022 can apply on the website.

Students who have successfully cleared BE/ BTech final year but yet to clear any backlog in any Semester of the earlier years are NOT eligible

Candidates to check their eligibility and fill application only if they meet the criteria.

# Medical Requirements

## **Physical Standards:**

- Candidates should be healthy and physically fit for sea service as per STCW 2010/MS Medical rules 2000 and all its amendment as applicable to seafarers.
- Aspirants to note that they have to undergo their medical examination with the company appointed DG Shipping approved doctor only. Any medical report acquired otherwise is **inadmissible and the candidate will have to undergo a medical examination with the company appointed doctor.**
- If the candidates want to check their fitness before undergoing the process, they are requested to get in touch with us over e-mail/phone. The candidate will have to bear the costs of such a test and the admissions team will only help arrange for such a test.

## **Eyesight:**

- Distance vision (unaided) : 6/12 in each eye; or 6/9 in better eye and 6/18 in other eye.
- Normal colour vision.

# Admission Process

## *Step by step admission process to join GEIMS:*

### **Step 1:**

- Apply online at [geinstitute.com](http://geinstitute.com) for the course you want to join and pay the examination fees.
- **Step 2:** You will receive a link over e-mail for an online examination that can be taken at any location. You will need to have a proper internet connection to do the same.
  - The login details as well as other instructions shall be provided in the e-mail.
  - Please make sure you provide the correct credentials (e-mail and phone number) while application.
- Link will be sent by our assessment partners.

- **Step 3:** If you clear the cut-offs (subject ), you shall receive an e-mail invite to appear for Personal Interview at either Mumbai or Lonavala. The details of the venue will be sent on the e-mail. The interview venue is decided in advance and is at the sole discretion of GEIMS. Candidate shall not be given a preference to select.

- **Step 4:** Those candidates who are selected in the personal interview shall undergo a medical test with the company appointed doctor.

- **Step 5:** Merit list will be prepared taking account past academic scores, online examination scores, interview scores as well as medical examination

- **Step 6:** Candidate who make it to the merit list shall be asked to pay a booking amount to reserve their seat.

- **Step 7:** After receiving the booking amount, the candidates will be issued with a sponsorship letter on the basis of which they can avail loans. We have a tie-up with State Bank of India for the loan process. The details of this shall be intimated to the candidates.

- **Step 8:** The candidates shall receive a joining instructions as well as other documents that they need to submit before they join. Candidates are encouraged to read the instructions carefully.

- **Step 9:** The candidates to report on the morning the course commences at GEIMS, Lonavala. The reporting date and time shall be intimated to the candidates.

## FAQs

- *Will accommodation be provided during the interview process?*

No, the institute does not provide accommodation. Candidates and accompanying guardians are to make their own arrangements for accommodation.

- *Is the booking amount/fees refundable?*

The fees and/or booking amount is not refundable under any circumstances.

- *Does the institute reimburse expenses incidental to the process?*

No, the institute does not reimburse any expenses whatsoever incidental to the process, unless specifically communicated.



# Online Examination

- The online exam will consist of the following subjects:
  1. English
  2. Logical Reasoning
  3. Mechanical Engineering
  4. Quantitative Aptitude
  5. General Awareness/ Knowledge
  6. Psychometric assessment
- Candidates will be called for interviews only after they meet the criteria laid down internally for the test.
- GE Shipping reserves the right to modify the cut-offs at their discretion.



# Fees

- The total fees for the GME course is INR **6,04,398**
- This includes tuition fees, boarding and lodging cost of professional books, safety items, uniforms accessories.
- Please note that the fee is subject to change and a notification shall be sent out in case of any change in the fees.

# How to apply?

Applicants who meet the eligibility criteria should apply by filling the Online Application Form on the website.

The Application should be submitted in the format given in the website only, with one recent passport size photograph pasted neatly in the right hand top corner.

- Communication regarding the exact interview date and time will be communicated to the applicants in due course of time. Applicants are requested to check the website and their registered e-mail ID continuously for details.
- Candidates must ensure they provide their correct email-id and phone number/mobile number in the online application form as they will receive the Test Login details on the email id mentioned in the application form.

## Career Path

The total training period is 18 months - 8 months on-shore and 10 months on board a ship as a Graduate Marine Engineer.

- After completion of training, it is mandatory to clear the examinations conducted by MMD and obtain requisite Certificate of Competency.

- 4th Engineer
- 3rd Engineer
- 2nd Engineer
- Chief Engineer

# Stipend & Salary

Stipend during the training period shall be determined by the market conditions as well as the organization that the trainees join for their training period.

## Employment

The Offer of admission for Pre-Sea Training and Shipboard Training by GES shall not be considered as guarantee of employment on completion of such training. However, in the event of GES offering employment after passing the Examination, the candidate shall agree to be bound to accept our employment and serve on our vessels for a period of three years. This is a requirement as per the Gazette Notification S.O.2132 (E) issued on December 12, 2007 by Govt. of India.

- Applicants are required to have a passport in hand before joining the course. If not, candidates are requested to apply for passport on an urgent basis.
- Eligibility criteria as laid down is sacrosanct and shall not be subject to change under

any circumstances.

- If any false / incorrect information furnished by the Applicant is detected at any stage, his/her candidature will not be considered and if selected, he will be removed from the training course and course fees will be forfeited.
- Course fees, advance fees, Examination fees once paid, will not be refunded, partly or otherwise, under any circumstances.
- As the applications are processed by a computerized system, it is essential that the application be forwarded strictly in accordance with the prescribed format.
- Duly filled in Application Form should have one photograph pasted and Demand Draft attached. Originals/photocopies of certificates etc. should not be sent with the application form.
- All fields in the Online Application Form should be filled with correct details and Application number/Enrollment number should be noted by the candidate for all future reference.
- Candidates should possess at least Twelve (12) recent passport size photographs (front view) and these photographs only must be used on Application Form, Interview, Medical Examination, training etc. Any change of photograph will disqualify the Candidate.
- Candidates, at the time of interview, will be required to produce original copies of proof of age, Degree Certificate, HSC Certificate or equivalent, SSC Certificate or equivalent, where applicable from Govt. recognized board/universities.
